Fubon Bank hereby advises that this fraudulent email is absolutely not related to Fubon Bank or Mr. James Yip, Executive Director of Fubon Bank and that Fubon Bank does not admit any liability for such fraudulent email.

To protect the privacy of its customers, Fubon Bank will never ask customers for sensitive information or personal data, such as customer reference number, account number, account password, etc by email.

Customers are reminded to be cautious of suspicious emails and to report such emails to Fubon Bank’s official enquiry numbers at 2566 8181 or 2842 6085.

Fubon Bank has already reported this matter to the Hong Kong Police and the Hong Kong Monetary Authority.
